

DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Police Federation of Australia

(E2016/284)

Arrangement for conduct of election.

[1] On 1 December 2016 and 6 December 2016 the Police Federation of Australia (the organisation) lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

Federal Executive Members (8)

Federal President Federal Vice Presidents (2) Federal Treasurer

[2] This is not the first time an election for these offices has been sought this year. Prescribed information was previously lodged by the organisation on 30 June 2016 in relation to an attendance ballot which was proposed to be conducted at the Annual Federal Council meeting scheduled to be held in New Zealand in November 2016 (E2016/172).

[3] Having regard to a range of relevant factors, including that the Australian Electoral Commission (AEC) had previously conducted similar elections for the organisation in New Zealand, on 9 August 2016 I issued a decision [[2016] FWCD 5238] under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009* (RO Act) arranging for the conduct of the election by the AEC.

[4] Following the issue of my decision, concerns were raised about the legitimacy of the AEC conducting elections for an Australian registered organisation in New Zealand.

[5] Upon subsequent review, I determined that the relevant provisions of the RO Act do not have extra-territorial effect, and therefore for an election to be validly conducted under the RO Act, it must be conducted in Australia. Once I determined that an attendance ballot under the RO Act could not validly be conducted in New Zealand, a clear implication emerged that my decision of 9 August 2016 could not be given effect by the AEC.

[6] Staff of the Commission then engaged with the organisation, which transacted rule alterations to facilitate an election by secret postal ballot in 2016. These alterations were

certified on 30 November 2016 [[2016] FWCD 8452]. The prescribed information lodged in December 2016 contemplates an election under the new rules.

[7] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

[8] For the avoidance of doubt this decision replaces [2016] FWCD 5238.

The Police Federation of Australia Federal Council met in New Zealand on 14th and 15th November 2016 and delegates carried a motion to amend the PFA Rules to allow the conduct of the 2016 Elections following certification of the new Rule 22(a), following the 2016 Federal Council meeting.
- 3. It is a collegiate election. The electorate for the elections are:
 - a) For the Federal Executive the electorate is the Federal Council as per Rule 20 (a) (i);
 - b) For the Federal President, Federal Vice Presidents and Federal Treasurer the electorate is the Federal Executive as per Rule 20 (a) (ii).
- 4. The closure of rolls for voting in the election will be as per Queensland Police Branch rule 47(b)(vii)
- 5. The voting system to be used in the conduct of the elections is first-pastthe-post system of voting.
