DECISION

Fair Work (Registered Organisations) Act 2009 s.189 – Arrangement for conduct of an election

Police Federation of Australia (E2011/2665)

Arrangement for conduct of election.

[1] On 27 September 2011 the Police Federation of Australia - Australian Federal Police Association Branch lodged with Fair Work Australia the prescribed information in relation to an election for the following offices:

ACT Policing Zone

Branch Zone Coordinator (insufficient nominations)
Branch Zone Workplace Delegates (4) (insufficient nominations)

Crime Operations Zone

Branch Zone Workplace Delegate

Human Resources Zone

Branch Zone Coordinator (casual vacancy)
Branch Zone Workplace Delegates (2) (insufficient nominations)

<u>Intelligence Zone</u>

Branch Zone Workplace Delegate (insufficient nominations)

Policy & Governance Zone

Branch Zone Coordinator (insufficient nominations)

- [2] In relation to the position of Branch Zone Workplace Delegate representing the Crime Operations Zone I have been informed by the Branch that an election is required for the position due to an increase in the membership of the Zone which would entitle the Zone to an additional position of Branch Zone Workplace Delegate. The rules of the branch provide that the number of Branch Zone Workplace Delegates is determined in accordance with a formula although it is acknowledged the rules do not provide a time as to when the formula is to be applied.
- [3] Nevertheless, the scheme of the Rules is such that persons elected to these positions are elected at the same time, save for the filling of a casual vacancy. The rules do not provide for the creation of an additional position of Branch Zone Workplace Delegate during a current term of

office. By contrast, the rules do provide for the election of Branch Zone Workplace Delegates where a new Zone has been established. Accordingly, I am not satisfied that an election for that position is required to be held under the rules at this time and I am therefore unable to make arrangements for the conduct of such election.

[4] I am satisfied, however, that an election for the remaining offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
