Organisation must respond to the post-election report of the Australian Electoral Commission: E2016/234

On 25/05/2017 the Registered Organisations Commission (the ROC) received a post election report from the Australian Electoral Commission (AEC) for election E2016/234 dated 25/05/2017. The AEC will have also provided the report to the organisation under section 197 of the Fair Work (Registered Organisations) Act 2009 (the RO Act).

The report identifies rules that were difficult to interpret or apply, in particular rules 73(c)(ii), 73(c), 73(c)(x), 73(g) and 73(i). This letter serves as a reminder of the obligations imposed on the organisation or branch as a consequence of the AEC's report. If a response has already been sent to the AEC and made available to all members please disregard this letter.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regs 141(4) and (5)).

A written response must be provided to the AEC

A written response must be provided to the AEC within 30 days of receipt of the report. The organisation's response must include whether the organisation or branch intends to take action and if so what action the organisation or branch intends to take (s198(2)).

Extract of report must be made available to members

The organisation or branch must make the section of the report relating to the difficult rules available to its members (s198(3)). This extract from the report must be made available to the members before or at the same time as the organisation's response is made available to members.

Written response must be made available to members

A copy of the organisation's response to the AEC must be made available to members either:

- within 30 days after the response is given to the AEC, or
- published in the next edition of the organisation or branch journal (s198(5))

Subsection 198(6) and regulation 142 prescribe ways in which the relevant extract and the copy of the response can be made available to members. These do not limit the ways in which they can be made available to members. The organisation will comply if it does all of the following:-

- publish the report extract and the copy of the response in the next edition of the organisation or branch's journal; and
- within 30 days of giving the response to the AEC:
 - lodges with the ROC a copy of the relevant extract and response, together with a declaration that a copy will be provided to any member who so requests; and
 - give notice in the next edition of the organisation or branch's journal, or an appropriate newspaper, that a copy of the relevant extract and response are available on request to each member free of charge; and
- publish the relevant extract on the website within 14 days after receiving the report, and publish the response on the website within 14 days of giving the response to the AEC (reg 142(2)).

Penalties may apply

If the organisation or branch does not:

- respond to the AEC within 30 days,
- make the extract of the report relating to the rules available to members no later than the organisation's response is made available to members, or
- make the organisation's response available to members within 30 days or in the next edition of the journal,

the organisation may face penalties under the RO Act. Each requirement listed above is a civil penalty provision that may result in fines for the organisation

As noted above, if the response and report have already been made available to members and the AEC, please disregard this letter. If you have any questions in relation to these obligations please contact the ROC for assistance by email to regorgs@roc.gov.au.

If the organisation or branch decides to alter its rules in response to the AEC's report

If the organisation or branch decides to alter its rules in response to the AEC's report, the ROC is NOT able to provide advice and assistance regarding draft alterations or the processes required to make the alterations. Rule alterations remain a function of the Fair Work Commission.

Post-Election Report E2016/234

I refer to your post-election report dated 25 May 2017 ("the 2017 Report").

I am aware that the AFPA is required to give a written response to the 2017 Report within 30 days of receipt of it, in accordance with Section 198 of the Fair Work (Registered Organisations) Act 2009 ('the RO Act').

I will ensure that the 2017 Report and the AFPA's response herein to that Report (and earlier reports referred to below) will be provided to members by publication on the AFPA website for a minimum period of three months from the date of this letter. Additionally, a copy of the Report and response will be made available to the Registered Organisations Commissioner.

The 2017 Report alerts our Association to a number of matters relating to one of the rules under which this election was conducted, namely then Rule numbered 73.

I also take this opportunity to note that previously you have made recommendations in relation to various rules of the AFPA in Reports on other AFPA elections in 2016, being reports respectively dated 1 June 2016, 24 June 2016 and 7 November 2016. The rules subject to comment were then rules 66 (b), 90 (a), 96 (c), 96 (e), 96 (f) and 114.

As you are aware from the AFPA's letters to you in response to each of those earlier Reports in 2016, the AFPA has recently undertaken a complete revision of its entire Rule book. That exercise provided the AFPA with a convenient opportunity to consider all of your recommended alterations to the Rules in those previous reports, but of course the new Rule book was adopted before the 2017 Report was received.

Mr Murray Furlong, Delegate of the General Manager Fair Work Commission, certified the new Rule book for the AFPA on 25 May 2017. The new Rule book incorporates all of the recommendations made in your previous reports in 2016. Furthermore, the new Rule book incorporates alterations that implement most but not all of the recommendations in the 2017 Report. Those recommendations from that Report that have not been implemented (namely previous Rules 73 (c) (i) and (ii) and 73 (g), now found in Rule 94) will be considered by the AFPA when it next needs to undertake rule alterations.

Other Matters

Rule 73 (c) (ii) Manner of Election

The part of this rule dealing with the re-opening of nominations is inefficient. It is proposed that the rule be changed to "re-call for nominations for offices where there are insufficient nominations received".

This allows that Returning Officer to:

- Send a Nominations Received report at the end of the closing of nominations identifying which
 offices may be contested/uncontested,
- Check and confirm validity and eligibility of candidates and nominations
- Declare uncontested offices at the meeting (or prior if preferred), and
- Re-call for nominations where there are insufficient number of nominees at the meeting, allowing another opportunity for members to nominate.

Other considerations to include in 73 (c) are:

- Rules pertaining to the withdrawal of nominations. It is recommended that candidates can withdraw up to the commencement of the meeting, this provides a 7 day consideration period.
- When recalling for nominations, the Branch should determine in the rules whether the Returning
 Officer recalls the whole office or part of the office. For example, if there are 6 vacancies for
 Executive Members and 5 candidates have already nominated, does the Returning Officer only
 open the 1 position or all 6 positions (which may impact on the balloting process and what is
 contested)?
- The Election Notice in 73 (c) (i) must state, that where there are insufficient nominations, the Returning Officer will re-call nominations at the meeting. This is <u>important</u> as there is insufficient time between the closing of nominations and the meeting to publish another notice re-calling for nominations.

Rule 73 (c) (x) Manner of Election

This rule may not always be possible where there are absent vote applications and the counting of ballot papers must occur after the meeting. This rule should be deleted.

Rule 73 (a) Scrutineers

It is recommended that "before the closing of nominations" is deleted from the rule allowing candidates to appoint scrutineers. It is not yet known whether the election is contested at the stage of nomination. Further, allowing candidates to appoint scrutineers at any time during the election would add to the integrity of the election process and provide flexibility for candidates when scrutineers are not available for certain activities of the election.

Rule 73 (i) Proxy Voting

This rule references Rule 87 (c) which states in part (ii), failing such appointment his/her vote or votes may be exercised on his/her behalf by any other delegate (if any) representing the same members of the Branch. This is problematic as there may be multiple delegate of the same branch and therefore a question of who will be entitled to exercise the vote. Secondly, it compromises the secrecy and integrity of the election. Whilst 87 (c) (ii) may work for the Branch's other business and motions, it should not be applied for an election. Rule 73 (i) should further state "with the exception of 87 (c) (ii) which does not apply to elections".

Arrangement for conduct of election.

- [1] On 15 November 2016 the Australian Federal Police Association Branch of the Police Federation of Australia (the Branch) lodged prescribed information in relation to an election in the Fair Work Commission.
- [2] On 23 December 2016 I certified alterations to the rules of the Branch. Amongst other things, those alterations altered the structure of the Branch by abolishing an office that would have otherwise been due for election, creating two new offices and renaming a number of other offices.
