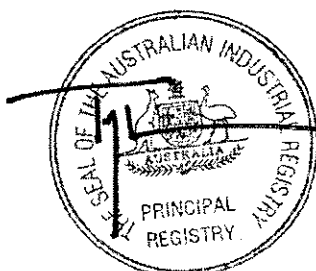



- (e) In the month of December in the year preceding the year the Biennial Conference is to be held, the President is required to request the Industrial Registrar to arrange for the conduct of elections for the positions of Conference Delegate, 52EG(e)(i).


