

The Police Federation of Australia, New South Wales Police Branch, hereby gives notice as follows:

(a) In accordance with rule 52EH (G) elections are required for the positions of Ordinary Branch Executive Members for the Greater Hume, Georges River and Commissioned Police Officers regions.
