The Police Federation of Australia, New South Wales Branch, hereby gives notice as follows:

- (a) In accordance with rule 52EG(a)(iii) elections are required for the positions of delegate to Branch Biennial Conference.
- (b) The elections are required, as the terms of office for delegates will expire on 13 April 2010.
- (c) All members in each region elect conference delegates on a proportional basis of one per 100 or part thereof members in each region. Rule 52EG(e)(iii)(a).
- (d) Annexure A details the number of members in each of the electoral regions as of 18 December 2009
- (e) Pursuant to rule 52EG(e)(iii)(a) the number of positions of conference delegates that are to be elected in each region is detailed in Annexure A
- (f) The electorate comprises only financial members of the respective Region (as set out in Annexure A) Police Federation of Australia, New South Wales Police Branch.
- (g) In the month of December in the year preceding the year the Biennial Conference is to be held, the President is required to request the Industrial Registrar (the General Manager of FWA as a consequence of the Fair Work (Registered Organisations) Act 2009) to arrange for the conduct of elections for the positions of Conference Delegate, 52EG(e)(i).
- (h) Rule 52EG(a)(ii) requires that elections be held for positions of ordinary Branch Executive members.

- (n) In the month of December in the year preceding the year the Biennial Conference is to be held, the President is required to request the Industrial Registrar (the General Manager of FWA as a consequence of the Fair Work (Registered Organisations) Act 2009) to arrange for the conduct of elections for the positions of Ordinary Executive members. Rule 52EG(e)(i).
- (o) The elections shall commence on the first Monday in February in 2010. Rule 52EG(e)(ii).
- (p) The electoral roll of members will close seven (7) days before the calling of nominations. Rule 52EG(e)(i)(a).
