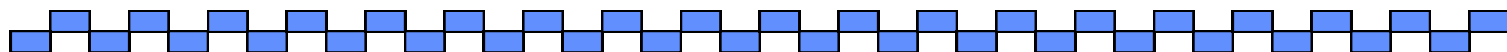

**STATEMENT IN ACCORDANCE WITH  
SUBSECTION 189 (1) OF THE ACT**

The Police Federation of Australia, New South Wales Police Branch, hereby gives notice as follows:

- a) In accordance with rule 52 EH (h) an election is required for a position of Ordinary Branch Executive Member Central Metropolitan Area 1. The period of office intended to be filled via the election is the remainder of the term of office.
- b) The election is required as the incumbent, Craig Partridge, has resigned his position as an Ordinary Branch Executive member effective 6 June 2013. A copy of his resignation letter is attached and marked A.
- c) The electorate comprises only financial members of the Member Central Metropolitan Region Area 1 of the Police Federation of Australia, New South Wales Police Branch. Rule 52 EG (b) (i) (1).
- d) The electoral roll of members will close seven (7) days before the calling of nominations. Rule 52EG(e)(i)(a).
- e) The returning officer shall determine the dates for the opening and closing of nominations and the opening and closing of the ballot 52 EH (h) (ii)
- f) The kind of voting system to be used in the conduct of the election is a direct voting System. Rules 52EG(e)(iii)
