52EG.e.xi.b The full names of candidates, for election for an office shall appear on the ballot paper for that election, shall have been drawn by ballot, at the close of the nominations or, in relation to candidates whose family names are identical, in the alphabetical order of their first or given names

The rule was difficult to apply at close of nominations since the rules does not account for a defect period. Section143(1) (c) of the Fair Work (RO) Act 2009 mandates that there must be at least a 7 day period to remedy any defects. The order of candidate names can only be drawn after close of nominations and any defect period that may be in effect.

Model Rule reference (if any):

14.1.4 The order of names in each ballot on the ballot paper shall be determined by lot drawn by the returning officer.

Other Matters

Returning Officer actions required (Section 193): Yes Details:

• Rules specifying the method of lodgement of nominations and candidate statements are set aside as the AEC held concerns that the coronavirus pandemic would impact on the ability for potential candidates to nominate. Instead, nominations will be received electronically, via email/the AEC's portal.

• Rules regarding the timetable of the election were set aside as the AEC held concerns that the coronavirus pandemic may impact on the ability for stakeholders to fully participate in the election. A timetable for the conduct of the ballot which varied from the rules was set when the AEC was satisfied that stakeholders would be able to fully participate.

• Ballot draw was not conducted at close of nomination as per Rule 52EG.e.xi.b. Ballot draw was conducted after close of nomination.
