

I have also received your letter of 31 March 2005 attaching the return for the Australian Federal Police Branch. The declaration was made in accordance with s.268(3) of the *Workplace Relations Act 1996*, but should have been in accordance with s.233(1) of **Schedule 1B of the** *Workplace Relations Act 1996* **which came into operation in May 2003.** The register of members is required to be kept in accordance with s.230(1)(a) of Schedule 1B for the preceding calendar year.

Please note that Regulation 147(e) of the Workplace Relations Regulations states that:

"(e) a record of each election that must, under the rules of the organisation, be held during each year commencing 1 January:"

in this case the year commencing 1 January 2005.

Please also note that s.233(2) of Schedule 1B of the Workplace Relations Act 1996 states

"(2) An organisation must, within the prescribed period, lodge in the Industrial Registry notification of any change made to the records required to be kept under paragraphs 230(1)(b), (c) and (d), certified by declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the changes made."

The prescribed period mentioned in this subsection is 35 days.

I look forward to receiving the amended declaration for the Australian Federal Police Association Branch certifying that the register of members as been kept and maintained in accordance with s.230 (1) and lodged in accordance with s.233(1) and including information concerning elections to be held in 2005.
