DECLARATION

Section 233(2) of the *Fair Work (Registered Organisations) Act 2009*

I, VINCENT MICHAEL KELLY, President (Police Federation of Australia, Northern Territory Branch) of 5 Foelsche Street Darwin in the Northern Territory of Australia do declare that:

1. I have caused a register of members to be kept during the 2011 calendar year and that it has been kept and maintained as required by Sections 230(1)(a) and (2) [s233(1)(a)].
2. Elections have been held in May 2011 for the positions of Branch President, Branch Vice President and five (5) Branch Executive Members. The President and Vice President were returned unopposed.
