**DECISION**

[1] On 10 July 2008, the South Australian Police Branch of the abovementioned organisation lodged in the Industrial Registry the prescribed information in relation to an election for the following offices:

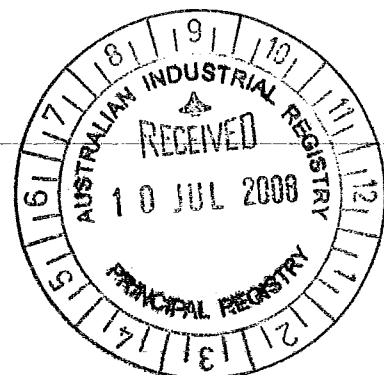
