Arrangement for conduct of election.

## **DECISION**

- [1] On 18 March 2008, the Tasmanian Police Branch of the abovenamed organisation lodged in the Industrial Registry the prescribed information in relation to an election for Chairperson, Secretary and three (3) Delegates to Branch Conference for the newly established Eastern Sub-Branch.
- [2] The prescribed information outlines that the Sub-Branch now exists as a result of the Branch creating an Eastern Sub-Branch at its Executive meeting on 20 February 2008, and the reason for the election is that the positions are new and need to be filled.
- [3] Subsection 189(3) of Schedule 1 provides that:
  - "(3) If:
    - (a) ....; and
    - (b) a Registrar is satisfied that an election is required to be held <u>under the rules</u> of the organisation or branch; and
    - (c) ...;

a Registrar must arrange for the conduct of the election by the AEC." (the underlining is mine)

- [4] The effect of rule 52BU of the Tasmanian Police Branch rules is to provide for District and Sub-Branch officers to be elected biennially with nominations closing not later than 1 October in the year of election. The last election for Sub-Branch offices was held in November 2007. The rules of the organisation or branch, however, make no specific provision for the conduct of an election to fill such positions between regular elections.
- [5] Accordingly, I am not satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation or branch at this time.
