I am an officer of the Tasmanian Branch of the Police Federation of Australia and am authorised to sign this statement, which is lodged in accordance with subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009. I request that you arrange elections with regard to the following information provided.

- 1. Elections are required for the following positions:
 - a) Eastern Sub-branch Secretary
 - b) Southern Sub-branch Chairperson
