Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices in matter E2019/102. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Police Federation of Australia-Tasmania Police Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;

- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

PRESCRIBED INFORMATION FOR ELECTIONS in accordance with Section 189 Fair Work (Registered Organisations) Act 2009 and Regulation 138 Fair Work (Registered Organisations) Regulations 2009

I am an officer of the Tasmanian Branch of the Police Federation of Australia and am authorised to sign this statement, which is prescribed for elections lodged in accordance with subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009. I request that you arrange elections with regard to the following information provided.

1. Elections are required for the positions of Chairperson, Secretary and Delegates to Branch Conference (3 positions) for each of the following Sub-branches:
 - Eastern Sub-branch
 - Southern Sub-branch
 - Western Sub-branch
 - Northern Sub-branch
 - Officers Sub-branch

2. The reason for the elections is that the terms of office for these positions will expire at the end of this year.

3. The electorates for the elections are:
 - For Chairperson, Secretary and Delegates to Branch Conference (3 positions) for the Eastern Sub-branch – the members of the Eastern Sub-branch.
 - For Chairperson, Secretary and Delegates to Branch Conference (3 positions) for the Southern Sub-branch – the members of the Southern Sub-branch.
 - For Chairperson, Secretary and Delegates to Branch Conference (3 positions) for the Western Sub-branch – the members of the Western Sub-branch.
 - For Chairperson, Secretary and Delegates to Branch Conference (3 positions) for the Northern Sub-branch – the members of the Northern Sub-branch.

- For Chairperson, Secretary and Delegates to Branch Conference (3 positions) for the Officers Sub-branch – the members of the Officers Sub-branch.
4. The date requested for nominations to open is at a date to be determined by the Returning Officer but no later than 15 September 2019 (rule 52BU(4)(b)).
 5. The date requested for nominations to close is at a date to be determined by the Returning Officer but no later than 12 noon on 10 October 2019 (rule 52BU(4)(e)).
 6. The date the roll of voters will close is at a date to be determined by the Returning Officer which will be 7 days before the day nominations are declared open (rule 52BU(4)(b)(ii)).
 7. The voting system that we request be employed is the direct voting system.
