Dear Bruce

I am writing to reiterate my advice to you during our conversation this morning.

In accordance with rule **52CF(17)(a)(i)** I agree that an eligible member of the Branch **may** be appointed by the Branch Committee to fill the Branch Officer (Senior Vice President) vacancy, as the unexpired portion of the term does not exceed three quarters of the term. I note for your information that the interpretation of rules of this kind has been that they do not deny an organisation the option of filling a casual vacancy by having an election conducted by the Australian Electoral Commission.

Regarding the amended prescribed information, rule **52CH(17)(a)(i)** and rule **52CH(17)(a)** are referred to in relation to the filling of the Branch Executive Member vacancy. My interpretation of the rules is that this rule pertains to casual vacancies in Branch Offices and that the relevant rule for the filling of vacancies of Branch Executive Member is rule **52CF(13)**. Under rule **52CF(13)(b)** an election is due for Branch Executive Member as the unexpired portion of the term exceeds one year. I note that if rule **52CH(17)(a)(i)** was applied, an election for Branch Executive member would not be required, as there is less than three quarters of the term remaining.

Finally, a statement is required in the prescribed information of the day provided for in the rules for the closure of the roll of voters. Under rule **52CF(5)** the roll of voters is closed 7 days before the day on which nominations open.

I am advised that as all Branch Officer positions are scheduled to be conducted in October 2010 as the unexpired portion of the office is short and an election is imminent (October 2010) the Branch Committee may fill the casual vacancy at a Branch Executive meeting. Rule 17(a) (b) which deals with casual Vacancies of Branch Officers merely states that the Branch Executive shall take immediate action to have such vacancy filled by an election conducted at a meeting of the Branch Executive. This rule differs to the filling of casual vacancies for a Branch Executive member where it clearly advises the process that must be followed.
