

Since inception, the Associated Body has carried out financial transactions including the collection of membership fees, the payment of accounts for expenses incurred in carrying out regular business (such as the production of a journal), has operated a bank account, has leased and/or owned property and office machinery, has employed and paid wages of employees.

Membership of the Branch and the Associated Body are identical and indistinguishable. No member of the Branch is ineligible for membership of the Associated Body. No prospective member has applied to be a member of the Branch and not also a member of the Associated Body.

The only financial concern of the Branch relates to the payment of capitation fees by the Branch to the Federal Fund (Rule 7) but this is paid by the Associated Body in accordance with Federal Rule 7 (a).

This is not to be read as inferring that the Branch does not function in a manner assumed by the Rules of the Police Federation of Australia. The Branch is fully operative in carrying out the Objects of the Union (Rule 4).

Officers of the Branch act for and appear for members in the Australian Industrial Relations Commission.
