Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Commission a declaration of results for the election [E2015/189]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Fair Work Commission (the Commission) within 35 days of any changes to the holders of office in the organisation. If the election has resulted in any changes to the holders of office, the Police Federation of Australia-Western Australia Police Branch must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated:
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and
 - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

As President of the Police Federation of Australia – Western Australia Police Branch (the Branch), I declare the following pursuant to Regulation 138(1) of the *Fair Work (Registered Organisations) Regulations 2009*.

The Prescribed Information I provided dated 17 June 2015, regarding the requirement to conduct an election for Executive Positions of the Branch, intended to include the election of: Executive Member positions; and Branch Office Bearers positions; and Delegates to Federal Council positions.

The System of Voting for the election(s) is as follows:

- Executive Member positions by **Direct** voting.
- Branch Office Bearers and Delegates to Federal Council by **Collegiate** electoral voting.

The number of Delegate to Federal Council positions to be elected is determined on proportional representation. The number of financial Members **as at 31 December 2014** was **6094.**

Information regarding the date on which the roll of voters is to close is contained at rule 52AO(2)(a), excerpt provided here for ease of reference:

- (2) Notice Inviting Nominations:
 - (a) The Returning Officer shall not less than 14 days and not more than 21 days before the date of commencement of the period for lodging nominations of candidates for an election for an office, cause to be published in either a newspaper circulating widely within the State, the "Police News" or Newsletter a notice stating that he or she is about to conduct elections for positions on the Executive of the Western Australia Police Branch of the Police Federation of Australia. The roll of voters shall close on the date of publication of the Returning Officer.

FAIR WORK (REGISTERED ORGANISATIONS) ACT 2009

PART 2 - CONDUCT OF ELECTIONS FOR OFFICE AND OTHER POSITIONS - SECTION 189 (1)

POLICE FEDERATION OF AUSTRALIA - WESTERN AUSTRALIA POLICE BRANCH

PRESCRIBED INFORMATION IN RESPECT OF AN ELECTION

I am an officer of the Police Federation of Australia – Western Australia Police Branch and am authorised by Rule 52AG, sub rule (4) as President to sign this statement which is lodged in accordance with the Fair Work (Registered Organisations) Act 2009 at Section 189 (1).

The Registered Rules of the Police Federation at Part CA — Western Australia Police Branch require:-

- 1. Rule 52AA (2) requires that the Executive shall be elected by and from the financial membership of the Branch, now numbering at the date of this statement, 6167.
- 2. Rule 52AA (2) provides that the Branch Executive for which the elections are required shall comprise 15 offices as under:-
 - 11 positions for the Metropolitan Region
 - One position for North (Kimberley/Pilbara) Region
 - One position for the Central (Midwest/Gascoyne) Region
 - One position for the East (Goldfields/Esperance) Region
 - One position for the South (Peel/Southwest/Wheatbelt/Great Southern) Region
- 3. Rule 52AA (3) provides that the General Election of Executive Members shall be held every three years.
- Rule 52AA (3) provides that the Returning Officer should conduct the election so as to allow declaration of the result not later than the 15th October, which for the current request will be 2015.
- 5. Rule 52AA (4) sets down the requirement for these elections which is the purpose for this request which arises from the impending normal course of events expiration of the term of office for the current Executive who were elected in 2012, and who hold office until the dissolution of the 2015 annual Conference, scheduled for 23rd and 24th November 2015. At the dissolution of that conference the Executive elect will commence their office.

- 6. Rule 52AO sub rules (2) and (3) provide for the intervals between the actions required of the Returning Officer, commencing with the publishing of a notice that the Returning Officer is about to conduct the elections for positions on the Executive of the Police Federation of Australia Western Australia Police Branch.
- 7. Rule 52AA (2) (b) provides that within 10 working days of the election result being declared, the Executive Elect shall meet to elect from within itself the following Branch Office Bearers prescribed in Rule 52AA (1).
- 8. Rule 52AF and 52AP further direct that the Federal Council Delegates also be elected, with the office of President being an *ex officio* Federal Council Delegate, and that the order in which elections conducted on a "first past the post" basis shall be:-

•	President (ex officio Federal Council Delegate)	1
•	Senior Vice President	1
•	Vice President	1
•	Treasurer	1
•	Federal Council Delegates	3

- 9. Rule 52AO (3) provides for the Returning Officer to determine the times and dates for nominations.
- 10. Rule 52AO (14) prescribes the Duties of the Returning Officer to determine the validity of votes and reject informal ballot papers; it provides for scrutiny, specifies that voting by proxy shall not be permitted and that voting for an office shall be by a preferential ballot.
