I acknowledge receipt by the Registered Organisations Commission (the ROC) on 5 February 2018 of your organisation's Annual Return which provides information under subsection 233(1) of the Fair Work (Registered Organisations) Act 2009 (the RO Act).

Thank-you for providing your Annual Return.

The documents lodged provide most of the required information for the 2018 Annual Return of the Queensland Real Estate Industrial Organisation of Employers.

Elections
