#### Dear Hayden,

I have examined the other document lodged, the Annual Return of Information under section 233 of the Fair Work (Registered Organisations) Act 2009.

The information seems to cover all the relevant prescribed categories in section 230 and regulation 147 but the declaration did not explicitly certify that the information provided was a correct statement of the information contained in the (original) records.

I notice that neither of the two previous returns included this explicit certification. In March 2011, a colleague in Fair Work Australia wrote raising this and I attach a copy of her letter.

Could I ask you to re-lodge a freshly signed declaration, amended to include the statement prescribed along the lines suggested in that letter? It will of course need to be signed by the President.

Arrangement for conduct of election.

[1] On 10 October 2012 the Real Estate Employers' Federation of South Australia and the Northern Territory lodged with Fair Work Australia the prescribed information in relation to an election for the following offices:

- [2] On 18 October 2012, Fair Work Australia advised the organization that the prescribed information was not lodged before the day prescribed by subregulation 138(3) of the Fair Work (Registered Organisations) Regulations 2009 ('the Regulation'), being the day occurring 2 months before the first day when a person may, under the rules of the organization or branch, become a candidate in the election. The President of the organization has stated that this was due to administrative oversight and lack of understanding of the requirement of the Regulation and has requested that I allow a later day for lodgment of the prescribed information under subsection 189(2) or the Fair Work (Registered Organisations) Act 2009. Having considered the reasons for late lodgment, I allow lodgment on 10 October 2012 in this instance.
- [3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the Fair Work (Registered Organisations) Act 2009, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
