#### President and Deputy President

On the 1 November 2012 Fair Work Australia (FWA) approved an arrangement for the conduct of an election for the following REEFSANT Officers, President and Deputy President. (E2012/383)

The Australian Electoral Commission (AEC) advised the REEFSANT that Nominations for the vacant positions opened on 7 November 2012 and closed on 21 November 2012. On the 22 November 2012 the AEC advised REEFSANT that a ballot was unnecessary that the positions were uncontested. Attached are the declaration documents.

#### **Vacant Position**

On the 30 August 2013 Fair Work Australia (FWA) approved an arrangement for the conduct of an election to fill one (1) vacant Board positions. (E2013/249)

The Australian Electoral Commission (AEC) advised the REEFSANT that Nominations for the vacant position will open on Monday 23 September 2013 and close on Tuesday 8 October 2013.

The AEC will send to all members the "Nomination Forms" by post. If the number of nominations does not exceed the number of vacancies, and all nominations are in order, a ballot will not be required. However, if a ballot is required, the ballot papers will be posted to all members on Tuesday 5 November 2013 and close on Tuesday 19 November 2013.

On the 9 October 2013 the AEC advised REEFSANT that a ballot was unnecessary that the positions were uncontested. Attached are the declaration documents.

#### Significant Rule Change 2012/13

The following "Notice of Motion" was presented to the REEFSANT Board at the 2 May 2013 Board meeting:

#### That:

- 1. The Rules of the Federation be altered so that, once altered, the Rules will be in the terms of Annexure "A" to this Notice of Motion, save that they will not reflect the marked up alterations.
- 2. These alterations are to take effect immediately upon consent to the alterations being granted in accordance Section 158 of the Fair Work (Registered Organisations) Act 2009 (Cth).

Additional changes to the rules are to be amended as follows:

1. Proxy nominations to be received one (1) hour prior to meetings.

The "Notice of Motion" and additional rule changes above were accepted and carried.

The amended rules were sent to the Fair Work Commission (FWC) by Tom Kidman (Crawford Legal) on 27 June 2013 for ratification by the FWC.

On 20 December the Fair Work Commission (FWC) notified REEFSANT by email the decision handed down by Mr Enright in Melbourne on 20 December 2013. (Refer attached)

Fair Work (Registered Organisations) Act 2009 s.159—Alteration of other rules of organisation

Alteration of other rules of organisation.

- [1] On 28 June 2013, the Real Estate Employers' Federation of South Australia and the Northern Territory (the REEFSANT) lodged with the Fair Work Commission (the Commission) a notice and declaration setting out particulars of alterations to the rules of the REEFSANT.
- [2] The particulars set out alterations to the Preamble of, and the insertion of new rules 9.5.3, 9.11, 9.12, 9.13 and 9.14 into, the rules of the REEFSANT. The alterations were made for the purpose of complying with provisions of the *Fair Work (Registered Organisations)* Amendment Act 2012 (the Amendment Act) regarding the rules of registered organisations. In particular, the alterations provide for specified disclosures, the implementation of policies relating to expenditure and the mandatory training of officers with duties that relate to the financial management of the organisation.
- [3] On 2 December 2013, the Commission wrote to the REEFSANT seeking confirmation that a notice had been published on the web site of the REEFSANT in accordance with regulation 126(1)(b) of the *Fair Work (Registered Organisations) Regulations 2009* (the Regulations).
- [4] On 20 December 2013, confirmation was given by the REEFSANT through its legal representative that a notice has been published on the web site of the REEFSANT noting that the notice of particulars was lodged with the Commission.
- [5] On the information contained in the notice, I am satisfied the alterations have been made under the rules of the organisation.
- [6] On 20 December 2013, the REEFSANT gave consent, under subsection 159(2) of the Fair Work (Registered Organisations) Act 2009, for the Delegate to make various amendments to the alterations for the purpose of correcting typographical, clerical or formal errors. Accordingly the following corrections have been made:
  - The second proposed sub-rule numbered 9.11.3 as it appears after sub-rule 9.12.2 was renumbered as 9.12.3.

- In the proposed sub-rule referred to above, the reference to "this Sub-rule" as it appears immediately after the words "any interests that are disclosed under" was omitted and replaced with the words "Sub-rule 9.12.1".
- [7] The Amendment Act<sup>1</sup> provides that alterations to rules of an organisation for the purpose of making provision as required by the Amendment Act can be certified by the General Manager during a transition period which commenced on 29 June 2012. Any alteration to rules that is certified during the transition period, however, does not take effect until the date of certification or the commencement of Part 2 of Schedule 1 to the Amendment Act, whichever occurs later. Part 2 of Schedule 1 to the Amendment Act commences on 1 January 2014.<sup>2</sup>
- [8] In my opinion, the alterations comply with and are not contrary to the Fair Work (Registered Organisations) Act 2009 (the RO Act), the Amendment Act, the Fair Work Act 2009, modern awards and enterprise agreements, and are not otherwise contrary to law. I certify accordingly under subsection 159(1) of the RO Act as modified by item 38 of Schedule 1 to the Amendment Act.
