Real Estate Employers Federation of South Australia (REEFSA) Election of Board Members

In accordance with the prescriptions of the Fair Work Act 2009, REEFSA, as a newly Federally Registered body, are required to call for nominations for the election of members to its board.

Rule 6.1.2 of the REEFSA Constitution requires not less than eight (8) Board Members. The Board Officer Bearers are President (1) and Deputy President (1). The newly elected Board Members must be elected before our Annual General Meeting which is tentatively scheduled for 25 November 2010.

As a general requirement under the Act all elections of office holders of our organisation are to be conducted by the Australian-Electoral-Commission-(AEC). We seek your assistance in commencing this process.

Hayden Creek, REEFSA Executive Office will provide the (AEC) with any administrative assistance during this process.
