I refer to your phone call 5 April 2004 requesting the lodgment of a revised declaration under the signature of an office bearer of the Association.


Please find enclosed a revised declaration as requested, signed by the President of the Restaurant & Catering Association of Victoria, Dur-e Dara OAM.
