

**RE: Financial Return for year ending 30 June 2013 - FR2013/462**

I refer to your letter dated 22 August 2014 and draw your attention to the attached Financial Reports and Declaration Certificate authorised by Mr Matteo Pignatelli on 5 November 2014.

I apologise for the delay in responding to your correspondence, however I have been overseas on other business commitments.

The purpose of this correspondence, in addition to the declaration, is to clarify the 'going concern' issues referred to in the audit statement raised in your letter of 22 August 2014.

The 'material uncertainty' over the ongoing viability of Restaurant & Catering Industrial is quite rightly raised by the auditor in absence of any further information on the nature of the entity. On closer examination, however, the operation of Restaurant & Catering Industrial is underwritten by Restaurant & Catering Industry Association of Australia Incorporated trading as Restaurant & Catering Australia.

The reason for both the material uncertainty and the significant losses sustained in the 2013 year is that assets and operating costs for that period and since have been 'transferred' to Restaurant & Catering Australia. Whilst for other purposes, the Governance of the two entities is completely separate, financial matters are entirely interdependent.

It is envisaged for the current financial year we shall apply for an exemption of the financial reporting requirements under s.271 of the Fair Work (Registered Organisations) Act 2009 subject to approval of the Fair Work Commission General Manager.

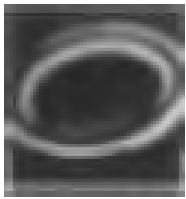
