Arrangement for conduct of election.

[1] On 27 June 2014 the Screen Producers Association of Australia lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

- [2] The organisation was informed that the prescribed information was not lodged before the day prescribed by Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*. That day is the day occurring 2 months before the first day when a person may, under the rules of the organisation or branch, become a candidate in the election. #### Prescribed Information for Screen Producers Association of Australia
