[1] On 18 February 2014 The Shearing Contractors' Association of Australia (the SCAA) lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

[2] The SCAA was informed that the prescribed information was not lodged before the day prescribed by Regulation 138(3) of the *Fair Work (Registered Organisations)* Regulations 2009. The closing date for nominations is two months prior to the AGM, or 17 March 2014. Nominations should be called for the election of the Management Committee from the

financial members of the Association by notice posted to them not less than fourteen days before the closing date for nominations, or 3 March 2014.

In the ballot to be conducted under rule 26 the day on which the roll of voters is to be closed, shall be on the fourteenth day prior to the opening of nominations.
