Further Information


3. Organisation to lodge on behalf of all branches next year

Section 233 of the *Fair Work (Registered Organisations) Act 2009* requires an organisation to lodge a declaration and copies of information with the Commission by the 31st March in each year. I note that in 2014 each branch of Shop, Distributive and Allied Employees Association lodged a declaration and the required information. As section 233 places the onus of lodgement on the organisation and not each branch, it is the view of the Commission that the national body of Shop, Distributive and Allied Employees Association is obliged to lodge all of the required information.

From 2015 the Commission intends to create one matter number for Shop, Distributive and Allied Employees Association, instead of a matter number for each branch of Shop, Distributive and Allied Employees Association. The national body of Shop, Distributive and Allied Employees Association will receive a reminder letter at the start of 2015. The branches will not receive a reminder letter.

From 2015 the national body of Shop, Distributive and Allied Employees Association is requested to collate and lodge the information regarding the national body of Shop, Distributive and Allied Employees Association and all of its branches. To assist with this task, I have attached a template annual return.
