The documents have been filed.

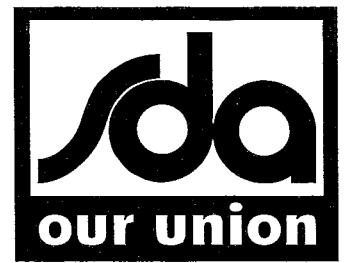




