Prescribed Information for election (section 189(1))

STATEMENT

I, <u>PETER MALINAUSKAS</u> of 69 Fullarton Road, Kent Town in the State of South Australia, Trade Union Secretary, make the following statement for the purposes of section 189(1) of the Act and regulation 138:

- 1. I am the Secretary/Treasurer of the Shop, Distributive and Allied Employees Association (SA Branch) and am authorised to sign this statement.
- 2. The prescribed information for the purposes of Regulation 138 is as follows:
 - 2.1. the name of each office and position in respect of which an election is required is:
 - 2.1.1. Branch Secretary/Treasurer (one position);
 - 2.1.2. National Councillor (six positions);
 - 2.2. the reason for the election is that the terms of office will expire during 2011 in the normal course of events;
 - 2.3. the electorate comprises only members of the South Australian Branch;
 - 2.4. nominations:
 - 2.4.1. must open no less than 7 days and no more than 14 days after the close of the roll of voters;
 - 2.4.2. must close no later than 12 noon on Wednesday, 4 May 2011;
 - 2.5. the roll of voters is to be closed on 31 March 2011;
 - 2.6. the voting system to be employed is a direct voting system.
