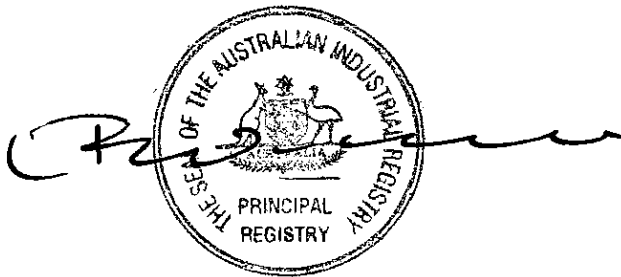

WORKPLACE RELATIONS REGULATIONS

**Prescribed Information Lodged Under S189 of Schedule 1B**

For the purpose of S189 of Schedule 1B of the Workplace Relations Act 1996, the following information is prescribed information:

- (a) An election is required in the Victorian Branch of the Shop, Distributive & Allied Employees' Association for the following office:

OFFICE	NUMBER OF THOSE OFFICES	ELECTORATE
Assistant Secretary- Treasurer	1	All financial members of the Victorian Branch as at the close of nominations

- (b) The reason for the election is that the term of the present office holder will expire in January 2004; being last filled by election for a four year term in an election declared on 18 January 2000;
- (c) The date and time of the commencement and expiration of the period during which nomination of candidates will be called or may be made under the Rules of the Branch in respect of the election are as specified by the Returning Officer.
- (d) The voting system to be employed in the conduct of the election is a direct election system.
- (e) The day provided for in the rules of the organisation on the day on which the roll of voters is to be closed is the date of close of nominations.
