Arrangement for conduct of election.

[1] On 19 November 2014 the Victorian Branch of the Shop, Distributive and Allied Employees Association lodged with the Fair Work Commission the prescribed information in relation to an election to fill a casual vacancy for the remainder of the term of office in the following office:

Branch Delegate to National Council (1)

- [2] The prescribed information was not lodged before the day prescribed by Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*. That day is the day occurring 2 months before the first day when a person may, under the rules of the organisation or branch, become a candidate in the election. The Branch has requested that I allow a later day for the lodgement of the prescribed information under subsection 189(2) of the *Fair Work (Registered Organisations) Act 2009*. # Fair Work (Registered Organisations) Act 2009 Statement and Notice of Prescribed Information

- I, MICHAEL JOHN DONOVAN, of 65 Southbank Boulevard, Southbank, Victoria make the following statement:
- 1. I am the Branch Secretary/Treasurer of the Shop, Distributive & Allied Employees' Association, Victorian Branch and I am authorised to lodge the following prescribed information concerning an election in the SDA Victorian Branch.
- 2. I confirm that the following information is being lodged under sub-section 189 (1) of the Fair Work (Registered Organisations) Act 2009 ("the Act").
- 3. SDA Victorian Branch Delegates to National Council were elected for a four year term on 9 January 2014. See attached declaration of the ballot by the Australian Electoral Commission.
- 4. One of the Victorian Branch Delegates to National Council elected on January 2014 was Lorraine Watson.
- By letter dated 14 November 2014 Lorraine Watson resigned from the office of Victorian Branch Delegate to National Council. See attached copy of the letter of resignation.
- 6. At a meeting of State Council held on 19<sup>th</sup> November 2014, the following resolution was passed:

"State Council notes that the resignation of Lorraine Watson dated 14 November 2014 means that there is a casual vacancy arising in the office of Branch Delegate to National Council and that more than three quarters of the term of office remains to be served. Pursuant to Rule 36 (ba) and Rule 44 (e)(1) State Council resolves that nominations shall be called on Monday 12 January 2014 for one (1) Branch Delegate to National Council and shall close at 10:30 am on Thursday 29<sup>th</sup> January 2015. If a ballot is required it shall open on Friday 27<sup>th</sup> February 2015 and close at 10am on Thursday 19 March 2015."

7. I provide the following prescribed information:

#### Prescribed Day

The prescribed day for the purposes of subsection 189(2) of the Act and for the purposes of the Fair Work (Registered Organisations) Regulations 2009 is the 12<sup>th</sup> November 2014. The SDA Victorian Branch seeks an extension of time to lodge the prescribed information up to 19<sup>th</sup> November 2014.
