Re: SDA WA Branch Elections

As discussed this morning the WA Branch of the SDA will not have the 25, 500 members required to achieve an entitlement to six National Council delegates by the time nominations are due to open in our elections.

Membership in January this year was 24, 600 – an all time record. In spite of the overall upward trend in membership, the Branch is affected by seasonal membership fluctuations with a Christmas peak and a mid year trough. Accordingly, I expect our membership will be below 25, 000 members at the time that the number of vacancies for National Council delegates needs to be determined and that, as a result, our entitlement to National Council delegates will remain at five for the purpose of the forthcoming election.
