Such information must be lodged once in each year at any time during the period of three months commencing 1 January.

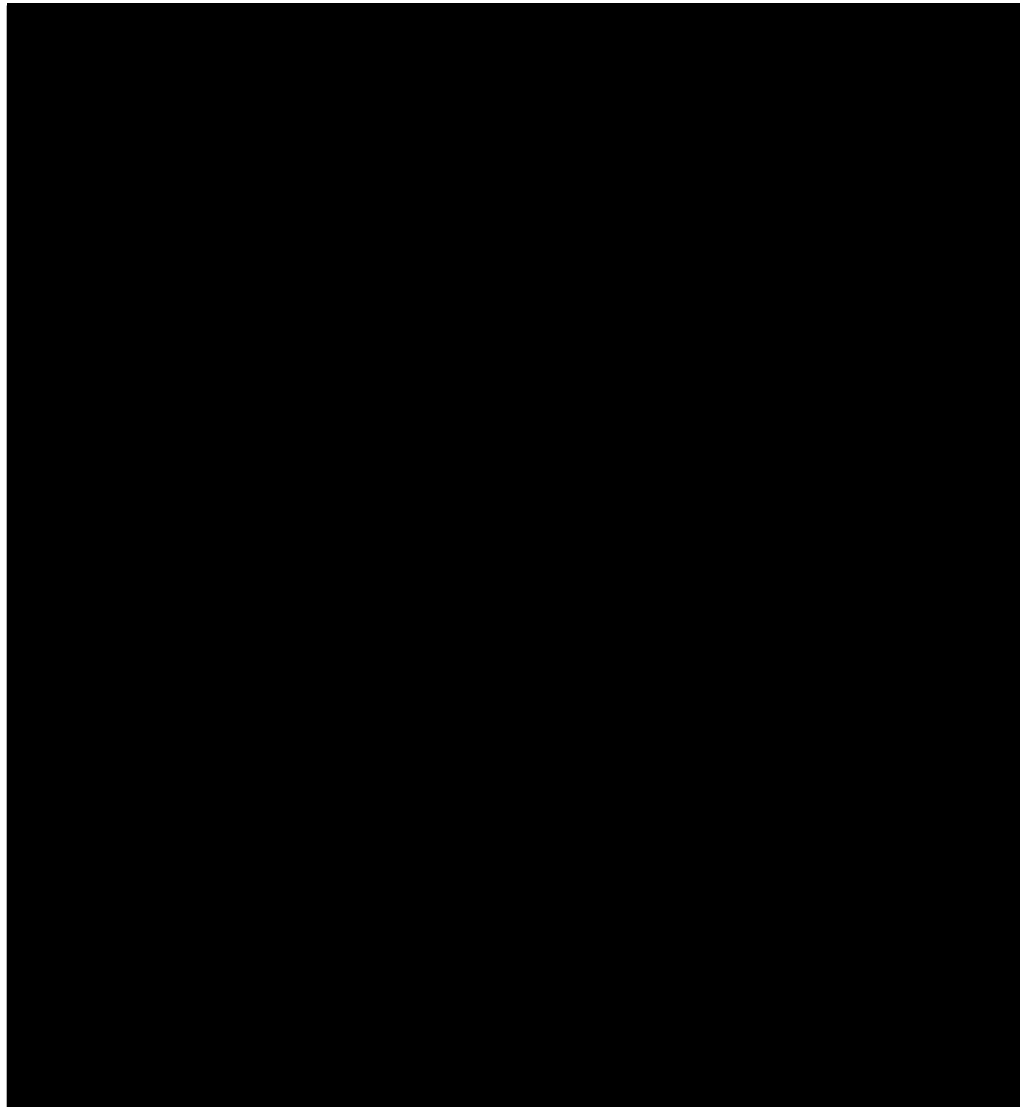
