REGULATION 138(1)(b):REASON FOR ELECTION

The reason for the election of each office or position set out above is that the term of each office or position has expired or is due to expire in the normal course of events.

REGULATION 138(1)(d): COMPOSITION OF ELECTORATE

The electorate comprises the members of the Queensland Branch.

REGULATION 138(1)(e): PERIOD FOR CALLING OF NOMINATIONS

The date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation are to be determined by the Returning Officer in accordance with rule 42(d)(ii).

REGULATION 138(1)(f): CLOSING OF ROLL OF VOTERS

Pursuant to rule 42(d)(iv)(ba) the roll of voters will close on the seventh day before the date determined for the opening of nominations.

REGULATION 138(1)(g): KIND OF VOTING SYSTEM

The kind of voting system to be used in the conduct of the election is a direct voting system.
