Annual Return of Information for 2014 [AR2014/145]

I acknowledge receipt on 13 January 2014 of your Declaration, providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009*.

The documents lodged cover the required information for the 2014 Annual Return of Information of TFGA Industrial Association.

I make the following comments to assist you when you next prepare an Annual Return of Information. You are not required to take any further action in respect of the documents lodged. The Fair Work Commission will confirm these concerns have been addressed prior to filing next year's Annual Return.

Section 233(1)(b) of the *Fair Work (Registered Organisations) Act 2009* requires the organisation to lodge a copy of records kept in accordance with s.230(1)(b), (c), and (d). This must be accompanied by a declaration that the *copy of records the organisation has lodged* is a correct statement of the information contained in the records kept by the organisation.

The declaration made by the organisation at paragraph 1(b) is worded as follows:

A copy of the records required to be kept under paragraphs 230 (1) (b), (c) and (d) and Regulation 147 of the Fair Work (Registered Organisations) Act 2009 is a correct statement of the information contained in those records.

This wording does not comply with s.233(1)(b). Please adjust this wording in future years. For example, the declaration might state:

The following is a correct statement of the information contained in the records required to be kept by the organisation in accordance with s.230(1)(b), (c), and (d) of the Fair Work (Registered Organisations) Act 2009.
