Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of stages 1 and 2 uncontested offices for [E2016/282]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the Fair Work (Registered Organisations) Act 2009 (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Timber Merchants' Association (Victoria), The must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held:
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and
 - the occupation of the person now holding the office.

A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Under section 189 of the Fair Work (Registered Organisations) Act 2009 (Cth), please accept the following prescribed information, which we submit in relation to forthcoming elections within the Timber Merchants Association (Victoria).

- 1. In compliance with Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009, please find the following information:
 - a. President
 Vice President (2)
 Committee Members (10)
 - b. The reason for the election is that the term of office for the above positions has expired in the normal course of events.
 - c. There is more than one position vacant in the offices of Committee Member (8) and Vice Presidents (2).
 - d. The primary electorate comprises members of the TMAV, who elect all Committee Members. Subsequently, those Committee Members elect the office bearers.
 - e. A period of not less than 60 days notice prior to the AGM is required.
 - f. The day provided for in the rules of the organisation as the day on which the roll of voters is to be closed is 7 days prior to opening nominations.
 - g. The kind of voting system to be used in the conduct of the election is:
 - i. Direct voting system (for Committee Member elections); and
 - ii. Collegial system (for office bearers).

In accordance with section 189(2) of the Fair Work (Registered Organisations) Act 2009 (Cth), the prescribed day occurs 2 months before the first day when a person may, under, under the rules of the TMAV, become a candidate in an election. The AGM is currently scheduled for May 2017.
