Re: Annual Return of Information Contained in Records of Organisation - s233 Fair Work (Registered Organisations) Act 2009 - Timber Trade Industrial Association (AR2013/318)

I refer to the declaration lodged pursuant to sub-section 233(1) of the *Fair Work (Registered Organisations) Act 2009* ('the Act') with the Fair Work Commission on 26 February 2013.

The declaration covered the following information:

- A statement that the register of members has been kept and maintained in accordance with subsections 230(1)(a) and 230(2);
- A list of the offices in the organisation, the names, addresses and occupations of persons holding those offices, and their occupations as prescribed by paragraphs 230(1)(b) and (c);
- Relevant records prescribed under paragraph 230(1)(d) including
 - the number of members as at 31 December 2012;
 - The address of the office of the organisation;
 - A statement in relation to elections due to be held in 2013.

A final statement certifies the statements contained in the declaration as true in every particular. I think this statement, read as a whole, means what is required by subsection 233(1)(b), namely, that the declaration certify that the lodged "copy of the records required to be kept under paragraphs 230(b), (c), and (d) is a correct statement of the information contained in those records". For the avoidance of doubt, this statement should in future reflect this wording.


DECLARATION OF AN ASSOCIATION
