



The Fair Work Commission has received your declaration dated 3 January 2014 and the attached list of Councillors, providing information in accordance with subsection 233 of the *Fair Work (Registered Organisations) Act 2009* [the "RO Act"]. The documents were lodged on 10 January 2014.

The declaration dated 3 January 2014 consistently refers to details required in the 2013 annual return, rather than those required in the current annual return. For example, in paragraph 3, the declaration states "as at 31 December 2012 there were 279 head office members", and in paragraph 6 it refers to an election held in 2013.



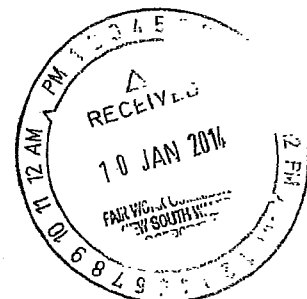


