

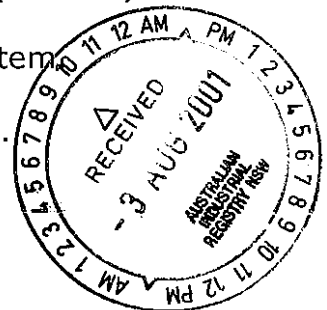
The voting system to be employed is a direct voting system.

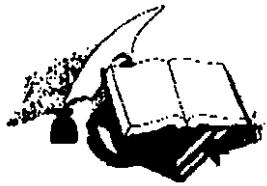
