Arrangement for conduct of election.

- On 11 October 2013, the Timber Trade Industrial Association lodged with the Fair Work Commission prescribed information in relation to an election.
- On 16 October 2013, the Fair Work Commission wrote to the Timber Trade Industrial Association to inform them that under section 189(2) of the Fair Work (Registered Organisations). 4ct 2009 (the Act) prescribed information must be lodged before the prescribed day, and that as on this occasion the prescribed information was not lodged before the prescribed day, a request for an extension of time would be required. The letter also requested the abevenuentioned organisation to confirm the number of Councillors and to specify who the electorate was for the scheduled election.
- [3] On 17 October 2013, the Timber Trade Industrial Association lodged with the Fair Work Commission amended and further prescribed information in relation to an election for the following offices:

Re: Arrangements for the conduct of an Election (E2013/285)

I refer to the prescribed information dated 8 October 2013 which was lodged with the Fair Work Commission on 11 October 2013 for the conduct of a scheduled election for offices of the Timber Trade Industrial Association.

Section 189(2) of the Fair Work (Registered Organisations) Act 2009 states that prescribed information must be lodged before the prescribed day, which under regulation 138(3) of the Fair Work (Registered Organisations) Regulations 2009 (the Regulations), is two months before the first day when a person may become a candidate. Under the organisation's rules, it appears that an election must be completed at least 14 days before the annual general meeting which is scheduled for 11 December 2013. Accordingly, It appears that the prescribed information was not lodged before the prescribed day.

Since s.189(2) is a civil penalty provision the Delegate of the General Manager will require a written request for an extension of time for lodging the prescribed information and providing reasons why the prescribed information was not lodged before the prescribed day.

In addition the prescribed information does not list who the electorate is for the purpose of regulation 138(1)(c) of the Regulations. Finally, the prescribed information does not provide the number of councillors who are to be elected for the 2013 quadrennial election. A copy of a resolution from the organisation or other pertinent documentation is required to satisfy and confirm the correct number of Councillors who are to be elected for the scheduled election.

Accordingly, please lodge amended and further prescribed information which satisfies the abovementioned requirements as soon as possible. If you have any questions relating to this correspondence please do not hesitate to contact me on (02) 8374 6509.
