## **AMENDING DECISION**

*Fair Work (Registered Organisations) Act 2009* s.189—Arrangement for conduct of an election

# **Traffic Management Association of Australia** (E2021/52)

Arrangement for conduct of election.

[1] On 1 April 2021, I issued a decision in this matter making arrangements for the conduct of a casual vacancy election by the Australian Electoral Commission (**the AEC**) for the office of Management Committee Member (Tasmania). As the Delegate of the Commissioner, I was satisfied that an election was required to be held under the rules of the organisation.

[2] As a result of the AEC suspending the conduct of many industrial elections due to the COVID-19 pandemic, this election (along with many others) was delayed, and the election in E2021/52 has yet to be conducted.

[3] On 7 October 2021, the organisation lodged prescribed information, in accordance with its rules, requesting a scheduled annual election (E2021/184) to fill offices of Management Committee Members (including the Tasmanian office) for a new term of office.

[4] On 22 October, I issued a decision making arrangements for the conduct of the scheduled election E2021/184 (Decision [2021] ROCD 165), i.e. the election for the new term of office, by the AEC. On 11 January 2022, the AEC declared election E2021/184, including the Tasmanian office that had previously been vacant.

[5] In circumstances where the original election decision in this matter (E2021/52) was to arrange for a casual vacancy election for the remainder of a term of office and that term of office has now concluded and a fresh term commenced by virtue of the declaration of election E2021/184, I confirm that the need for the election in E2021/52 has been superseded and the AEC is therefore no longer required to conduct the election for the office under E2021/52.
