Annual Return of Information for year 2011 – AR 2011/2568**

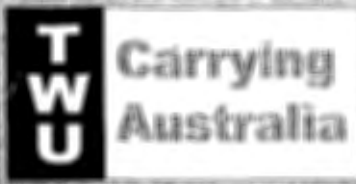


