



The ROC aims to help organisations comply with all the requirements of subsection 233(1) of the RO Act. I make the following comments to assist with future lodgements.

**Full list of branch elections**

The Annual Return requires the organisation to provide a copy of the record of 'each election that must, under the rules of the organisation, be held during each year commencing 1 January... for an office in a branch of the organisation' (see regulation 147). I note that the Annual Return stated under branch elections that 'Quadrennial Elections for directly elected positions in each of the Branches'. The note then continues to add, 'The precise positions that each Branch requires an election for will be notified to the Registered Organisations Commission when it lodges the Prescribed Information'.

### Time frames

Regulation 151 of the *Fair Work (Registered Organisations) Regulations 2009* prescribes that a notification of change pursuant to section 233(2) of the RO Act must be lodged within 35 days of
