

I have compared the lodged election request with the current TWU Rules and the prior TWU election decision in 2006.

Would you be able to provide the following additional information as soon as practicable:

- 1. Branch membership figures to confirm that the correct number of Federal Councillors are allocated to each Branch as per Rule 24(2).
- 2. Confirmation that the number of SA BCOM Members has decreased from 8 in 2006 to 7 in 2010.
- 3. Confirmation that SA has a Br Assist Sec in 2010 (though it did not have a Br Assist Sec in 2006).
- 4. Confirmation that the number of Branch Organisers in Vic/Tas has reduced from 13 in 2006 to 6 in 2010.

- 5. Confirmation that the number of Branch Organisers in SA has reduced from 3 in 2006 to 0 in 2010.
- 6. Confirmation that the number of Branch Organisers in WA has increased from 3 in 2006 to 4 in 2010.
- A supplementary election request for NSW Br Pres, VP, Assist Sec and Br Trustees (3) to be included in the present election – as per NSW Rule 11 in Annexure F (it is noted that these collegiately elected positions were included in the 2006 election decision covering the other TWU positions).
