Dear Mr Mulholland,

Thank you for the 2010 Annual Return of the New South Wales Branch of the Transport Workers' Union of Australia. The Annual Return covers the required information with one exception, which is information relating to elections. Regulation 147(e) of the Fair Work (Registered Organisations) Regulations 2009 requires the provision of information "of each election that must, under the rules of the organisation, be held during each year commencing 1 January: (i) for an office in the organisation...", that is, information relating to elections are required for the year commencing 1 January in the reporting year.
