The documents have been filed and no further action is requested.

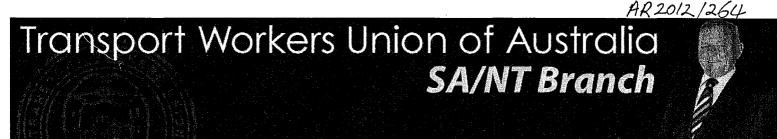
