Annual Lodgement of Information for the year 2013

I acknowledge receipt of your Declaration from the following branches of the Transport Workers' Union of Australia: the New South Wales Branch, the Victorian/Tasmanian Branch, the Western Australia Branch and the Queensland Branch, providing information in accordance with subsection 233(1) of the Fair Work (Registered Organisations) Act 2009.

The documents lodged cover the required information for the 2014 annual return of the Transport Workers' Union of Australia.

The annual returns will be placed on a website maintained by Fair Work Commission at http://www.e-airc.gov.au/179V/.

New requirement for 2015 Annual Returns

Section 233 of the Fair Work (Registered Organisations) Act 2009 requires an organisation to lodge a declaration and copies of information with the Fair Work Commission (the Commission) by the 31st March in each year. I note that in 2014 each branch of the Transport Workers' Union of Australia lodged a declaration and the required information. As section 233 places the onus of lodgement on the organisation and not each branch, it is the view of the Commission that the national body of the Transport Workers' Union of Australia is obliged to lodge all of the required information.

From 2015 the Commission intends to create one matter number for the Transport Workers' Union of Australia, instead of a matter number for each branch of the Transport Workers' Union of Australia. The national body of Transport Workers' Union of Australia will receive a reminder letter at the start of 2015. The branches will not receive a reminder letter.
