As was advised in the letter to the Commission from the former Branch Secretary of the Transport Workers' Union of Australia Western Australian Branch, Mr Jim McGiveron, by letter dated 5 December 2012, there have been changes to the persons who are holding the offices of Branch Secretary and Assistant Branch Secretary in the Western Australian Branch of the Union.
