



 - 1.2 In the Victorian Branch, pursuant to Victorian Branch RULE 1:
 - One (1) Branch President
 - One (1) Vice-President
 - One (1) Junior Vice President
 - One (1) Secretary
 - Four (4) Trustees
 - Seven (7) Committee persons
 - 1.3 In the Queensland Branch, pursuant to Queensland Branch **RULE 1**:
 - One (1) Branch President
 - One (1) Vice-President
 - One (1) Junior Vice President
 - One (1) Secretary
 - One (1) Assistant Secretary
 - Three (3) Trustees
 - Eight (8) Officer Delegates*
 - Eleven (11) Firefighter Delegates*

- 2. The election is required for the reason that the terms of office of the above Offices, which are determined by Rule 70 Election of Branch President, Vice-Presidents, Secretary, Assistant Secretary, Trustees, Members of Branch Committee of Management and Australian Government Employees Branch Organisers, will have expired.
- 3. The voting system to be employed in elections for Branch Offices is a direct voting system.
- 4. The electorates for Branch Offices are as follows:

- 4.1 In the case of the New South Wales Branch, members of the New South Wales Branch shall pursuant to the Rules, be eligible to nominate and vote for NSW Branch Offices provided, however, that the following qualifications, pursuant to NSW Branch Rule 1, shall apply:
 - 4.1.1 Of the ten (10) Committeepersons, one (1) shall be employed within the Sydney North area (NSW Fire Brigades' Zones N1 and N2), one (1) shall be employed within the Central Coast area (NSW Fire Brigades' Zone N7), one (1) shall be employed within the Newcastle area (NSW Fire Brigades' Zone N3), one (1) shall be employed within the Sydney South area (NSW Fire Brigades' Zones S1 and S2), one (1) shall be employed within the Illawarra area (NSW Fire Brigades' Zone S3), one (1) shall be employed within the Sydney North West area (NSW Fire Brigades' Zones NW1 and NW2), one (1) shall be employed within the Sydney South West area (NSW Fire Brigades' Zones SW1 and SW2), one (1) shall be employed within the Country area (NSW Fire Brigades' Zones N4, N5, N6, NW3, NW4, NW5, SW3, S4, S5), one (1) shall be from the Senior Officers' section of the Branch and one (1) shall be from the Retained section of the Branch.
 - 4.1.2 All members shall be eligible to nominate for and shall participate in the election of the President, Vice President, Junior Vice President and Secretary..
 - 4.1.3 The Committeepersons namely,

Sydney North
Sydney North West
Sydney South West
Sydney South
Newcastle
Central Coast
Illawarra
Country

shall at the time of nomination for election be permanent full-time firefighters holding the rank of Station Officer or below and be employed within the area represented by that Committeeperson.

- 4.1.4 A member nominating for election to the position of Senior Officers' Committeeperson shall be employed as a permanent full time firefighter holding a rank above the rank of Station Officer.
- 4.1.5 A member nominating for election to the position of Retained Committeeperson shall be employed as a retained firefighter.
- 4.1.6 In the election of the ten (10) Committeeperson positions, nominations shall only be received by the Returning Officer in such a way that the representational requirements of (4.1.1) hereof are fulfilled. All members shall participate in the election of each of the Committeepersons.
- 4.2 In the case of the Victorian Branch, members of the Victorian Branch shall, pursuant to the Rules, be eligible to nominate and vote for Victorian Branch Offices provided, however, that the following qualifications, pursuant to Victorian Branch Rule 1, shall apply:

- 4.2.1 Of the seven (7) Committee members, two (2) shall be Officers employed by the Metropolitan Fire and Emergency Services Board, two (2) shall be firefighters employed by the Metropolitan Fire and Emergency Services Board, one (1) shall be an Officer employed by the Country Fire Authority and one (1) shall be a firefighter employed by the Country Fire Authority, one shall be a member of the Union who is not employed by either the Metropolitan Fire and Emergency Services Board or the Country Fire Authority as an operational employee who may or may not be an operational member but who is employed by another organisation that is eligible for membership under these rules.
- 4.3 The electorate for the Queensland Branch Offices are as follows:
 - 4.3.1 In the case of the Queensland Branch, members of the Queensland Branch shall, pursuant to the rules, be eligible to nominate and vote for Queensland Branch Offices provided, however, that the following qualifications, pursuant to Queensland Branch Rule 1, shall apply:
 - 4.3.2 For the purposes of electing the eight (8) Officer Delegates, the eleven (11) Firefighter Delegates, the one (1) Senior Officer Delegate, the one (1) Communications Delegate, the one (1) Auxiliary Firefighter Delegate, there shall be eleven (11) electoral districts. Only persons who are Firefighters at the close of nominations will be eligible to nominate for a Firefighter Delegates position, only those persons who are Officers at the close of nominations will be eligible to nominate for an Officer Delegates position, only those persons who are Senior Officers at the close of nominations will be eligible to nominate for a Senior Officers Delegate position, only those persons employed in Communications and who are a member of the Union at the close of nominations will be eligible to nominate for a Communications Delegates position and only those persons who are Auxiliary Firefighters at the close of nominations will be eligible to nominate for an Auxiliary Firefighter Delegates position. All financial members within a region are eligible to vote for both Officer and Firefighter Delegates positions.
- In the case of the West Australian Branch, members of the West Australian Branch shall, pursuant to the Rules, be eligible to nominate and vote for West Australian Branch Offices provided, however, that the following qualifications, pursuant to West Australian Branch Rule 3, shall apply:
 - 4.4.1 Of the eleven (11) Ordinary Committee members, five (5) shall be Officers, five (5) shall be Firefighters and one (1) shall be a financial member of the Branch not employed as an Officer or as a Firefighter.
 - 4.4.2 Of the three (3) Trustees, one (1) shall be an Officer, one (1) shall be a Firefighter and the third Trustee's office shall be open to any financial member of the Branch.
 - 4.4.3 Of the two (2) Vice-Presidents, one (1) shall be an Officer and one (1) shall be a Firefighter.
- 4.5 In the case of the South Australian Branch, members of the South Australian Branch shall, pursuant to the Rules, be eligible to nominate and vote for South Australian Branch Offices provided, however, that the following qualifications, pursuant to South Australian Branch Rule 1, shall apply:

- 4.5.1 Of the six (6) Ordinary Committee members, three (3) shall be Officers and three (3) shall be Firefighters.
- 4.5.2 Of the two (2) Vice-Presidents, one (1) shall be an Officer and one (1) shall be a Firefighter.
- 4.6 In the case of the Tasmanian Branch, members of the Tasmanian Branch shall, pursuant to the Rules, be eligible to nominate and vote for Tasmanian Branch, pursuant to Tasmanian Branch Rule 1.
- 4.7 In the case of the Australian Government Employees Branch, members of the Australian Government Employees Branch shall, pursuant to the Rules, be eligible to nominate and vote for Australian Government Employees Branch Offices provided, however, that the following qualifications, pursuant to Rules 56(2) and 70(4), shall apply:
 - 4.7.1 Of the eight (8) Committee members, one (1) shall be elected from each of the States and Territories on the following basis:
 - By members employed in the State of New South Wales
 - By members employed in the State of Victoria
 - By members employed in the State of Queensland
 - By members employed in the State of South Australia
 - By members employed in the State of West Australia
 - By members employed in the State of Tasmania
 - By members employed in the Australian Capital Territory
 - By members employed in the Northern Territory
 - 4.7.2 Of the sixteen (16) Branch organisers, one shall be elected from each of the Rescue and Firefighting Units as detailed below:
 - By members employed at Sydney
 - By members employed at Melbourne
 - By members employed at Brisbane
 - By members employed at Perth
 - By members employed at Adelaide
 - By members employed at Canberra
 - By members employed at Hobart
 - By members employed at Darwin
 - By members employed at Launceston
 - By members employed at Alice Springs
 - By members employed at Cairns
 - By members employed at Coolangatta
 - By members employed at Mackay
 - By members employed at Rockhampton
 - By members employed at Karratha
 - By members employed at Port Headland
- 4.8 In the case of the Australian Capital Territory Branch, members of the Australian Capital Territory Branch shall, pursuant to Australian Capital Territory Branch Rule 7 be eligible to nominate and vote for Australian Capital Territory Branch Offices.

- 5. Nominations for Officers in all Branches shall open on the 10th March, 2000 and nominations shall close on the 31st March, 2000, pursuant to sub-rule 74(1).
- 6. In the event that an election for any of the ongoing positions is required, ballot papers will be posted to the membership on the 21 April, 2000, pursuant to sub-rule 27(10)(a) and the ballot will close at 5pm on the 7th May, 2000, pursuant to sub-rule 27(10(b), or such other time and date as may be determined by the Returning Officer.

PART 2 NATIONAL OFFICES

- 1. An election is required for the Offices of National President and National Secretary pursuant to Rules 12 and 24.
- 2. The election is required for the reason that the terms of office of the Officers referred to in paragraph 1 above, which are determined by Rule 23 Election of National Officers, will have expired.
- 3. The voting system to be employed is a collegiate voting system.
- 4. Nominations for National Offices shall open on 1st August, 2000, and nominations shall close on 19th August, 2000, or such time and date as may be determined by the Returning Officer.




