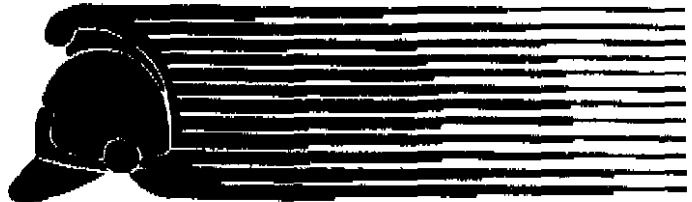

Re: United Firefighters Union of Australia Elections

Dear Sir,

I am currently in the position of Acting National Secretary for the United Firefighters Union of Australia.

It is my understanding that as part of my duties, I am obligated to notify yourself as per Section 214 of the Workplace Relations Act 1996 in regard to the United Firefighters Union of Australia elections.

It is also my understanding that I am required to provide you with the prescribed information in relation to the election of the relevant office's. In this regard I have attached a copy of the prescribed office's for each branch.

Rule 74 (1) of the United Firefighters Union of Australia states as follows:

- (1) *Nominations for the position of President, Vice-President, Secretary, Trustee, Committee of Management Member, Organiser or National Delegate of a Branch shall not later than 31st March in each year in which there is a general election for these positions be either delivered to the Registered Office of the Branch addressed to the Branch Returning Officer or delivered to the Branch Returning Officer.*

As can be seen by the above Rule, nominations must be received by no later than the 31st March.

Further, Rule 70 (1) states as follows:


- (1) *Presidents, Vice-Presidents, Secretaries, Assistant Secretaries where required, Trustees, Members of Branch Committee of Management and National Delegates of Branches shall be elected every three years and shall hold office from the time of the declaration of their election.*

As can also be seen from the above Rule, the relevant officers shall be elected every three years. In this context, I respectfully request that you arrange for elections to be held for the officers detailed in the prescribed information due to the term of the current elected office's expiring 31 March, 2003.

Further, in relation to our secondary election for the position of National Secretary and National President, could you please also make provisions for such elections. Please note that in this regard the ballot for the last election closed on the 31 October, 2000.

Thank you for your assistance in this matter. If you require any further assistance please do not hesitate to contact me.

Heidi,

Re our conversation this morning regarding the UFUA election notification faxed on 6 January:

The information required to be included in an election notification is set out in regulation 61 of the Workplace Relations Regulations 1996, which I have set out below.

The areas where some additional information is required for this notification are paras(1)(d) & (1)(f), which refer to the electorates for the various positions and to the method of election for those positions. Also, in any case where the number of persons to be elected is dependent on membership numbers (e.g. Queensland Branch Firefighter Delegates), we require details of the membership numbers of the relevant section of the union at the relevant time.

I have had a look at the last scheduled election file in year 2000 and a brief look at the rules, which indicate that there are various electorates for various positions.

I attach below a scanned copy of the notification forwarded for the 2000 elections which may be of some use - I think there may have been changes to some relevant rules since then so the actual detail may need to be different.

I notice that the notification includes positions for the "Australian Government Employees Branch" which I think has effectively been replaced by the "Aviation Branch", I have not looked further to see whether the representation has changed but you may wish to check that as well.

You may wish to draft up a replacement notification and fax or email it in to us to look over before getting it signed etc., but otherwise just relodge an amended notification. Paul Herrod who will be processing the notification should be back at work on Monday.

61. Prescribed information in respect of election - subsection 214 (1) of the Act

(1) For the purposes of subsection 214 (1) of the Act, the following information is prescribed information:

- (a) the name of each office in respect of which an election is required;
- (b) the reason for the election, being:

- (i) that the term of the office has expired; or
- (ii) that there is a casual vacancy in the office; or
- (iii) that a new office has been created;

(c) where more than one of the offices in respect of which an election is required has the same name and the number of such offices can, in accordance with the rules of the relevant organisation or branch, be ascertained before the prescribed day the number of those offices;

(d) where the electorate comprises only members of a branch, section or other division of an organisation - the name of that branch, section or division, as the case may be;

(e) the date and time of the commencement and expiration of the period during which nominations of candidates will be called for or may be made under the rules of the organisation or branch in respect of the election;

(f) the voting system to be employed in the conduct of the election, being:

- (i) a direct voting system; or**
- (ii) a collegiate electoral system.**

(2) The prescribed information lodged in accordance with subsection 214 (1) of the Act shall be accompanied by a statement signed by an officer of the organisation or branch lodging the information who is authorised to sign the statement to the effect that the information is being lodged in accordance with subsection 214 (1) of the Act.

(3) For the purposes of subsection 214 (1) of the Act, the prescribed day is the day occurring 2 months before the first day on which a person may, under the rules of the organisation or branch, become a candidate in an election.

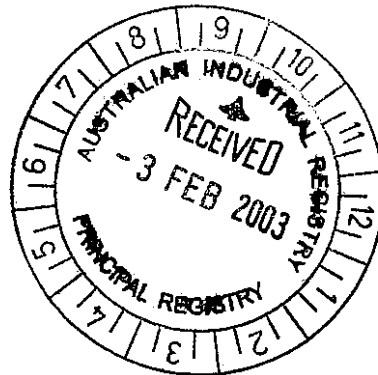

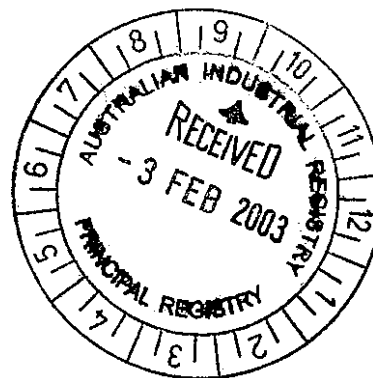

8.3 The electorate for the positions of Branch Vice Presidents consists of the Branch Committee of Management [**Subrule 56(2)**] *x not required*

8.4 The electorate for each position of *Branch Organiser* consists of all members of the Branch employed in the Rescue and Firefighting Unit which that Branch Organiser represents and who are financial at the time when nominations for the elections close.

E – DATE AND TIME OF COMMENCEMENT AND EXPIRATION OF NOMINATION PERIOD

1. Rule 74(2) provides that a Branch Returning Officer shall call for nominations by notice, which shall be displayed in the registered office of a Branch and at work areas and be published in the Union journal and in other ways likely to come to the attention of the members of the Branch.
2. Rule 74 (1) provides that nominations for Branch positions must be delivered to the Branch Returning Officer or to the Registered office of the Branch addressed to the Branch Returning Officer by 31 March in each year in which there is a general election for these positions.

F – VOTING SYSTEM TO BE EMPLOYED

1. The election in respect of the positions of *Aviation Branch Vice Presidents* is conducted by a collegiate voting system. *x not required*
2. The election of all other positions listed in Part A above is conducted by a direct voting system.

PART 2 – NATIONAL OFFICES

A - OFFICES FOR WHICH AN ELECTION IS REQUIRED

An election is required for the Offices of National President and National Secretary in accordance with Rules 12 and 23.

B – REASON FOR ELECTION

In accordance with subrule 23(1), the National President and National Secretary shall be elected every third National Committee of Management Annual Meeting. This meeting is due to be held in October with final dates to be advised when confirmed.

C – NUMBER OF OFFICES

Refer to A above

D – COMPOSITION OF ELECTORATE






