Arrangement for conduct of election.

[1] On 20 December 2012 the United Firefighters' Union of Australia lodged with Fair Work Australia the prescribed information in relation to an election for the following offices:

National President National Secretary

- [2] The prescribed information was not lodged before the day prescribed by Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*. That day is the day occurring 2 months before the first day when a person may, under the rules of the organisation or branch, become a candidate in the election. The National Secretary of the organisation has stated that this was due to the scheduling of the organisation's National Committee of Management meeting and has requested that I allow a later day for lodgment of the prescribed information under subsection 189(2) of the *Fair Work (Registered Organisations) Act 2009* (the Act). Having considered the reason for late lodgment, I allow lodgment on 20 December 2012 in this instance.
- [3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Prescribed Information for National Elections

The United Firefighters Union of Australia (UFUA) received correspondence from Fair Work Australia in May 2012 advising us that the elections of National President and National Secretary were due to expire in 2012 as the last election was conducted by the Australian Electoral Commission in 2009, however the records from the AEC indicate that the National President and National Secretary were declared elected on 2 February 2010, rather than in 2009.

We discussed the matter of national elections with FWA in the context of when the National Committee of Management meetings were held as FWA had on record that the National Meetings were held in October/November each year.

The UFUA advised via correspondence to Fair Work Australia on 7 September 2012 that the Annual Meeting for the National Committee of Management is held in February/March each year.

The National Committee of Management has met via teleconference today to set the annual meeting for 2013 which will be the Election Meeting. The date for the National Committee of Management meeting has been set for 12 and 13 March 2013. As 2013 will be 3 years since the election of the National Offices, please find attached prescribed information for the National Elections.

The UFUA respectfully makes application under section 189(2) of the Fair Work Australia (Registered Organisations) Act 2009 for the General Manager to allow a later period in which the prescribed information is provided. The reason the extension request is made is
